# Squash New Zealand

M Dowson, SquashNZ CEO joined the meeting at 6.20pm.

Mr Dowson discussed the following points:

- NZ Open: significant interest and leverage to be gained from it for future years
- Affiliation model: changes to be discussed with districts



- iSquash replacement: delay in rollout and functionality changes
- Facility plan SW requested to provide feedback on plan's consistency with local knowledge
- Trends in Membership numbers (although some Wellington clubs yet to file data)

M Dowson left the meeting at 6.45pm

#### Finances

R Henderson spoke to the financial information provided in the Board pack and took questions.

A Smith advised that a grant application to the Lion Foundation for \$30K in respect of the GM's salary was pending.

The Board **noted** the information presented.

The Board agreed that a 2022 budget reforecast should be prepared for use at the November planning meeting with a view to being able to agree a draft 2023 budget at that meeting from which a schedule of grant funding applications can be prepared.

## Operations

The Board **agreed** to provide clubs with awards nominations on request to support the making of strong nominations in future years.

The inaugural powhiri for the Inter-District Teams event hosted by Hutt City Squash was reported to have been enthusiastically received.

## Use of Club K for SW office

The Board discussed the draft MOU for use by SW of the Club K office space. The Board requested further information from Squash New Zealand on their actual operational expenses to be able to estimate the dollar amount of SW's proposed 5% share.

The document should be revised and recirculated to incorporate minor amendments discussed at the meeting.

#### Action #2022/30 C Sayer

On whether Club K was obliged to pay affiliation fees to Squash Wellington, the Board did not have the relevant information at hand to resolve whether the anecdotal 3% of profits had been enshrined in a binding agreement. The GM was requested to follow up.

#### **General business**

The Board discussion paper on roles and responsibilities regarding selection decisions was deferred for consideration. The Board **noted** that role descriptions already exist so that the proposed task of



drafting role descriptions for selections could be downgraded to merely amending those descriptions, if required.

- 1. Budget with a view to sharing in early February 2023 ready for a March AGM;
- 2. Selection roles and responsibilities
