To foster increased opportunities to play squash in the wider Wellington region through the delivery of competitions, tournaments and training programmes which people across all sectors of the population can access.

Description and Quantification of the Entity's Outputs

We were very happy to retain the numbers of participants in our 2023 HEAD 9Hundy & Below Junior series, with a slight increase from 88 to 90. This forms an important and effective pipeline as junior players 'graduate' to mainstream tournaments while new J Graders take their place. Due to popular demand, we have increased the number of rounds once again in 2024, this time from seven to nine, and rebranded the series as the 'HEAD Junior Series', following the introduction of the new grading system.

The women's series saw a slight decrease in numbers, following a more dramatic drop in between the previous two seasons. In 2023, we increased the grade threshold to include the whole of E grade in response to some women players who were overgraded for the series but not quite ready to focus on mainstream tournaments. We did see a dedicated core of women who took part in most rounds, and in 2024 we have once again increased the number of rounds, this time to seven.

We saw an excellent Wellington Open at Hutt City in 2023. Whilst the numbers weren't quite at the heights of 2022, this wasn't of particular concern, as it was widely reported across the district that tournament attendance dropped a little in 2023. No doubt this was related to people travelling more than they had done during the COVID-affected years.

The numbers in the Wellington Squad Programme have continued to grow. 2023 is looking to be bigger still as the series develops.

Once again, we saw the number of graded players in Wellington stabilise in 2023, following a growth in 2022. However, early indicators show that this number is again on the grow into the current season.

'How did we do our accounting?'

Basis of Preparation

The entity has elected to apply PBE SFR-A (NFP) Public Benefit Entity Accrual (Not-For-Profit) on the basis that it does not have public accountability and has total annual expenses equal to or less than \$2,000,000. All transactions in the Performance Report are reported using the accrual basis of accounting. The Performance Report is prepared under the assumption that the entity will continue to operate in the foreseeable future.

Goods and Services Tax (GST)

The entity is registered for GST. All amounts are stated exclusive of goods and services tax (GST) except for accounts payable and accounts receivable which are stated inclusive of GST.

Goods and Services Tax (GST) (Alternate Note)

The entity is not registered for GST. Therefore all amounts are stated inclusive of GST (if any).

Income Tax

SQUASH WELLINGTON DISTRICTS INC. is wholly exempt from New Zealand income tax having fully complied with all statutory conditions for these exemptions.

Bank Accounts and Cash

Bank accounts and cash in the Statement of Cash Flows comprise cash balances and bank balances (including short term deposits) with original maturities of 90 days or less.

Changes in Accounting Policies (Alternate Note)

The policy in respect of the basis of preparation has changed during the year to permit the entity to comply with the entity to comply with Generally Accepted Accounting Practice by applying the PBESFR-A (NFP) framework. The change provides reliable, relevant information to users by presenting the financial information in a way that is understandable. The change in policy has impacted the financial reports by changing the presentation of the financial information only. All other policies have been applied consistently.
